I also worked with her when she went to work in the U.S. Attorney's Office in Great Falls. This was the first opportunity I had to observe her working in the courtroom. She was always


prepared and was able to anticipate what might come up as a legal issue in each trial or motion hearing or evidentiary hearing or change of plea hearing or sentencing.
