

My name is Savannah Hanson, I am the Clerk of District Court in McCone County. McCone County is part of Department Two along with Richland County within the Seventh Judicial District. I am writing to express my concerns, opinions, and recommendation for the upcoming Judge appointment.

There are four candidates who are seeking the position. Two of the four candidates live in Dawson County, and two live in Richland County. In my professional and personal opinion, it would be beneficial if the appointed Judge lived in Richland County since that is where the majority of the workload will take place.

The citizens, taxpayers, and parties in Court proceedings along with myself would like a Judge that will be in person for hearings and bring back courtroom etiquette and professionalism. McCone County has not had a Judge in person for a hearing since January of 2020. I realize the Covid pandemic played a part of that for a while, but it is time to get back into the Courtroom.

The appointment should be made to the candidate who has experience in all aspects of the multiple types of cases including jury trial experience. The Clerk of Court's Office has been implemented with Full Court Enterprise, which is the program used by Clerks, Attorneys and Judges for filing cases and it would be highly beneficial if the candidate has experience and knowledge of this program. This program is an important key to the daily operations of the Clerk of Court's Office. I noticed not one candidate expressed that they have experience or use of this program. However, I do know that at least two of the candidates are using Full Court Enterprise. Those two candidates are Brett Irigoien and Charity McLarty.

Several candidates have received letters of recommendation from citizens in Dawson County. Although Dawson County is in the Seventh Judicial District, this appointment is for the Judge position in Department two that would mainly handle cases in Richland and McCone County. Financially it would be smart if the Judge did not have to travel from Dawson County to Richland County daily and if they aren't planning on driving daily, then I would assume they would appear by zoom, which is not what the people want. I understand in certain circumstances where zoom would be beneficial but for most hearings, I feel the Judge should be present in the Courtroom.




