

Ladies and Gentlemen:

It is a privilege to submit this letter of recommendation on behalf of Charles Brentley Brooks, who is an applicant for a Montana Thirteenth Judicial District Court Judge position. Mr. Brooks, who was Billings City Attorney for 22 years, was a colleague for two years when I was Billings Assistant City Administrator and then reported directly to me for 11 years when I was Billings City Administrator.

Mr. Brooks will bring to the bench an extensive history in both civil and criminal legal work. While with the City of Billings, he supervised a staff of 15 civil and criminal attorneys, and supporting staff in providing all aspects of the city's legal activities. Prior to his time with the city, he was a law clerk for James F. Battin, Chief Judge of the United States District Court, District of Montana. We need more judges like Judge Battin. I can think of no attorney better suited to become a judge and more likely to follow Judge Battin's example than Brent Brooks. Judge Battin was a consequential
