Dear Governor Gianforte:

I am writing to register my confidence in Daniel M. Guzynski in his application for the 9th Judicial District Court (Glacier, Pondera, Teton and Toole counties). The chance to have a candidate of his quality for the 9th Judgeship is an opportunity not to be missed. His significant work in the courtroom requires a solid working knowledge of evidence and procedure which is such a bonus when it comes to taking the bench. Civil matters and written motions allow a judge to educate themselves on their own time in chambers. The pace of a jury trial requires rapid decisions on objections which can compromise the case and create appellate error. Trial experience in the wide ways a case can go sideways in an instant is critical.

My primary knowledge of Mr. Guzynski is based on the cases he has tried and or handled before me. His cases are complex or political because that is what his office handles when requested by the county attorney. One case upon which I sat was a difficult, long, and highly contested case. Pretrial motions included 120 motions or sub-motions. Opposing counsel was often rude to everyone in the courtroom but to protect the record and the defendant's rights, I attempted to be even handed, balancing my rulings before the jury to assure the Defendant did not pay for the behavior of his counsel. There were many times I would not have been surprised to have Mr. Guzynski react to the aggravation that was constant. Instead, he remained professional, and above the fray. As a former trial lawyer, I know the best results come with good counsel on both sides. It is much more difficult when one side is behaving badly. Having been assisted by Prosecutor Service Bureau when I was the Lake County Attorney in the 90's, they were great to have as backup. Losing him as the Bureau Chief for Prosecution Services Bureau will be a loss to the County Attorneys but Mr. Guzynski could bring so much to the bench. With the travel responsibilities PSB attorneys take on to handle cases, it is time we put him to work on the bench.

I have watched Mr. Guzynski be a tremendous asset to our state in helping new or overwhelmed county attorneys with difficult, political, or unusual cases. Mr. Guzynski's performance as an attorney and then head of that office is consistent with what I received from his first boss, John Connor when John assisted me with the last capital case tried to conclusion in my first year as Lake County Attorney, and former Captain in the U.S. Army Judge Advocate General Corps, Bureau Chief, Attorney General and then Governor Marc Racicot in the position Mr. Guzynski now holds.

Mr. Guzynski is the consummate professional. He is grounded in the value system, the truth, the law and the rights of the Defendant regardless of an unethical defendant's counsel would deliberately attempt to derail a serious, ugly sexual intercourse/incest trial. In his work he demonstrates the tradition of hard work of his office in a manner of some of his predecessors, John Connor and Marc Racicot. 
Dear Judicial Nomination Committee:

Governor Gianforte,

I am the district judge in northeastern Montana, I am in my 29th year on the bench.

In the last decade I have presided over about a half dozen major criminal trials across the state where Daniel Guzynski was one of the prosecutors. Dan (because Guzynski is as difficult to type as Cybulski) sticks in my memory more than most prosecutors because my observation was he placed fairness and honesty in the proceedings above his desire to win. Don't get me wrong, he is a competent, zealous, hardworking and successful prosecutor, but my observations are that Dan would not allow the proceedings to become unfair just to gain an advantage or advance his case. Dan goes out of his way to insure the proceedings stay fair.

Dan has a compassion, respect and kindness that he showed to all of the participants in proceedings, whether it was a potential juror in a sex crime trial who would have been uncomfortable listening to the testimony because of some trauma in their life, to a witness with difficulty recounting painful memories.

The desire that proceedings be fair and follow the law are a District Judge's highest priority. At the start of a trial I like to tell jury panels that I like to win, and I win if we have a fair trial following the rules. Almost every legal proceeding leaves some participants feeling they lost. If litigants know they were treated fairly, their voice was heard, and the law was followed, they leave with respect for the court system and the Judge's decision.

I am also going to suggest that when you look at an attorney's legal background and areas of practice for someone to be a judge, please remember, legal research and understanding the state of the law, in any area, is much simpler when you don't have an agenda, or a side that you are advocating for.

I am writing in support of Dan Guzynski for appointment as District Court Judge to the Montana Ninth Judicial District Court. Dan is fair, balanced, professional, and a highly qualified trial attorney. He would make an excellent judge.


I first met Dan in 2008 when he prosecuted a homicide in Havre that I presided over as a district judge. The trial had some very difficult evidentiary issues, problems with witnesses, and involved the felony-murder doctrine. There were security concerns requiring I take special measures to ensure safety of the jury, witnesses, and court staff. The trial spanned approximately two weeks and provided numerous opportunities for the defense to build in appealable error. It is at these times that a trial judge is very grateful to have a skilled and experienced prosecutor who has common sense and integrity. Dan knew when to make concessions to the defense, without jeopardizing his case before the jury. He was skilled in laying foundations for the admission of evidence; admitting evidence; and examining witnesses. His demeanor was always professional and respectful, to me as well as court staff and the public. During the trial, one of the jurors had his car scratched with a key and believed a member of the defendant's family was responsible. Dan's questions of the juror in chambers regarding the incident were appropriate and ensured the trial could go forward without appealable error. Dan also opted for a jury instruction on the felony-murder doctrine which, while still correct, was less favorable to his case. In doing so, he again avoided building in potential appealable error. Dan's understanding of Montana law and his skillful and reasoned prosecution of the case resulted in the conviction being affirmed on appeal. His expertise saved valuable judicial and court resources and avoided the victim's family from having to go through the ordeal of a retrial.

Since I have been on the Montana Supreme Court, I have also reviewed cases that Dan has prosecuted. In these cases, as well, Dan has demonstrated his knowledge of the law and skillful prosecution. He is a fair and reasoned prosecutor who is highly respected throughout Montana. Like Dan, I also was a prosecutor and I was most comfortable trying criminal cases. However, the trial experience I gained from trying serious felonies and addressing numerous constitutional and evidentiary issues was excellent preparation for handling the complex civil litigation that came before me as a district judge. Dan's experience in front of a jury and his handling of complex constitutional and evidentiary issues will serve him well as a trial judge, and he will have no difficulty picking up any civil matter that comes before the district courts.

Finally, and probably most important, Dan will appreciate the nonpartisan responsibility of being a judge. He is an attorney with a strong commitment to the law. He understands the role of the courts and the difference between being an advocate and a judge. He has been, and will continue to be, a true public servant who willingly offers his legal expertise for the benefit of this State. Dan will represent Montana well and I strongly recommend him for appointment as District Court Judge to the Montana Ninth Judicial District Court.



recollection. I lost that appeal. I've lost many appeals in which Dan was trial counsel for the State of Montana.



One of my favorite stories about Dan came from a survivor he had worked with over a decade ago. She told me a story about Dan baking her cookies, bringing them to a meeting with the defense team, and, instead of having a chance to eat the cookies, they watched as the defense attorney gobbled them all down. Despite the horrendous circumstances that brought this survivor and Dan together, this is the memory this survivor carries with her. She and the countless other survivors Dan has worked with remember him for his kindness and ability to support them through traumatic, atrocious experiences.

The criminal justice system is offender-centric and often does not consider the worries, concerns, and trauma experienced by victims and their families. Dan is the exception in this system. He has left lasting impressions on the hearts of those he has supported. Some survivors remember him for his cookies, others for his ability to truly hear their stories. He has helped and guided people with significant trauma through additional traumatic experiences and through a system that often does not listen to their voices. Dan has given victims and their families a voice in a system not built to include them.

When I began my career in systems-based victim services in Montana, Dan sat down with me to discuss how we could work together. Over the years, we collaborated to ensure survivors have voices during parole hearings. We have also collaborated to increase victim services from victimization through sentencing and into post-conviction.

Dan has diligently championed victims and their families, going so far as to sit and support them during parole hearings. Parole hearings force a survivor to relive their trauma, often years after it has occurred. Dan and I have talked extensively about this process, the trauma it can cause, and the best way we can work together to support the victims of Montana through such a trying time.

Dan's experience, compassion, and ability to balance offender rehabilitation, public safety, and victim care make him an exceptional candidate for judge. He takes a comprehensive view and would bring his significant background and balanced moral view to a system that needs truly compassionate and good people to bring change.


