
I am writing this letter to express support for Deputy County Attorney (DCA) Molly Owen regarding her application for district court judge of the 20th Judicial District of Montana. My name is Mathieu Gfroerer and I have worked as a law enforcement officer in Montana for over 13 years.

Working with DCA Owen, I have repeatedly been impressed by her professionalism and genuine care for victims of violent crime. I can think of two specific cases where DCA Owen went above and beyond what I've come to expect. DCA Owen's diligence and determination resulted in a repeat domestic abuser finally, after years and years of slipping through the cracks in a lower court, being held accountable for their actions. As the level of violence between the two parties had continued to progress, I truly believe her work on that case saved at least one life from being lost.

The second instance involved a homeless woman who was a repeat victim of PFMA. The female generally refused to work with law enforcement and expressed she had no faith our judicial system would do anything to keep her safe or hold her abuser accountable. DCA Owen, having watched a body-worn camera recording of the female's statement, reached out to local officers in attempt to locate and speak with the female directly. DCA Owen was eventually able to meet with the female. Unfortunately, despite DCA Owen's efforts, the female passed away in an unrelated incident prior to seeing the justice system work for her.

It is my opinion, DCA Owen would enforce Montana law impartially and hold offenders accountable for their actions, while also being compassionate toward the public and victims of the 20th Judicial District. Thank you for your time and consideration.
