I have had the pleasure of knowing Alex for the last 10+ years, both professionally and personally. We met in Montana at a shooting competition and I am proud to say that I have had an opportunity to develop a friendship with him. I am a 20 year veteran of the Grand Forks Police Department in North Dakota with assignments in Patrol, Investigations, Narcotics, and Tactical operations. I had 15 years serving on the Grand Forks Regional SWAT Team, including 3 years as Team Leader. I am a North Dakota Peace Officer Standards and Training certified instructor. I have taught law enforcement classes at the North Dakota Law Enforcement Training Academy and at Lake Region State College in their Peace Officer Training Program in the area of firearms, high risk traffic stops, and tactical operations.

Alex has always shown me that he truly lives a life of service, to his country and community. From his time in the Marine Corps, his time in law enforcement with the Stillwater County Sheriff's office, his time in law school at the University of Miami and then as a licensed attorney acting as a public defender, Alex has always tried his very best to ensure that he was of service to those around him. He volunteers for several veteran's related groups, serving on the Board of Directors for Dog Tag Buddies and Warrior Wishes of Montana, which are groups working to assist veterans. While I am sure that the other candidates for this position will talk about their service to the community, Alex has put his life on the line in service to the country and his community. After the September 11th attacks, Alex left college and volunteered for the Marine Corps. He was deployed to Iraq with the 3rd Battalion 25th Marine Regiment in 2005 and his battalion was one of the most heavily engaged in the entire conflict while

serving in the Al Anbar region of Iraq. The 3rd Battalion 25th Marine Regiment was tasked with training the Iraqi Security Forces (ISF) and conducting stability and security operations to prevent insurgents from gaining a foothold in and around the cities of Iraq's Al Anbar province. After completing his Marine Corp service, Alex completed his bachelor's degree at MSU- Billings and began his time in law enforcement with the Stillwater County Sheriff's Office. He made the decision to apply for law school and was then accepted to the University of Miami Law School. Upon completion of law school, Alex took the Montana Bar exam and passed on his first attempt, in October of 2013.

Alex has spent the vast majority of his legal career as a criminal defense attorney. He opened his own practice straight out of law school and set out to provide excellent service to his clients. He took on the duties of a public defender and has diligently worked to provide the best legal service for his clients, whether they were obtained or appointed. I have personally witnessed Alex put in many hours working on a case on weekends and evenings because he wanted to ensure that he was providing his clients with the highest level of service. He has worked without support staff, doing research and case preparation without assistance. He has worked throughout eastern Montana and has vast trial experience. I am writing this letter to express my support for Alexander Roth's appointment to replace the Honorable Judge Todd in Yellowstone County.




Dear Governor Gianforte:

Alexander Roth would be a good judge because:

- He brings a fresh perspective to a courthouse that has struggled unsuccessfully with rising crime rates and overcrowded dockets, despite being given large amounts of additional resources. Unlike the other applicants, he is not a longstanding local government employee. That might be a disadvantage if things were going well in county legal matters, but in my view they are not.
- He is a combat veteran. While not essential to the job, it shows dedication and brings a certain broader perspective to the task. Although Yellowstone County has a very large veteran population, to my knowledge there is not a single judge or prosecutor here—federal, state or local—who has served in combat.
